Sir/Madam,

I am directed to inform you that the candidate whose details are given in the annexure overleaf has been provisionally selected for a Government of India Merit Scholarship subject to the fulfilment of means test. The scholarships under the Scheme are awarded to the candidates whose parental income does not exceed Rs.500/- per month.

The scholarship will be subject to the terms and conditions detailed in the attached note and the value of the scholarship will be fixed in accordance with para 2 of the note.

In case you are willing to avail yourself of the scholarship for your ward on the terms and conditions prescribed in this regard, you should convey your acceptance to the undersigned immediately on receipt of this letter. If your income exceeds Rs.500/- per month, this offer may be treated as cancelled. Definition of INCOME has been given in the enclosed terms and conditions.

In case you accept the offer and fulfil the required
MEANS TEST:-

- (i) Immediate steps should be taken for the admission of your ward to the school to which he/she has been nominated:
- (ii) You should have your ward medically examined by a Competent medical authority, i.e., Civil Surgeon/Assistant Surgeon or a Registered Medical Practitioner and the certificate should be submitted to the Principal of the school to which your ward has been nominated: and
- (iii) As required in para 4 of the terms and conditions of the award, the parent/guardian should immediately submit a declaration of income for

the year 1976-1977 in the enclosed proforma in duplicate, one copy to be forwarded to this Ministry immediately and the other to the Head of the Institution (to which your ward has been nominated) at the time of admission. The scholarship will be confirmed only on the receipt of this income declaration and other documents referred to above.

It may be noted clearly that the offer of scholarship/admission to approved residential school of your ward would remain provisional till income declaration and Scheduled Caste/Scheduled Tribe certificate (in the prescribed form, as per specimen attached) submitted by the guardian/parent are received & found satisfactory by the Ministry for the purpose of eligibility of your ward for Merit Scholarship.
